ORDER

Norms for granting University research fellowship was issued vide U.O. read as (1) above. The Syndicate, vide paper read as (2) above, considered the increasing number of requests for condoning the delay occurred in fulfilling the conditions for the extension of the University research fellowship and resolved to constitute a sub-committee comprising of Dr.K.G Gopchandran, Convenor, Standing Committee of the Syndicate on Academics and Research, Dr. P.M Radhamany, Member Syndicate, the Director Research and the Deans of Faculties of Applied Sciences and Technology, Science, Commerce, Oriental Studies, Social Sciences and Arts to study the matter in detail and to submit the report.

The Syndicate vide paper read as (3) above, considered the minutes of the above sub-committee held on 21.02.2021 along with the recommendation of the Standing Committee of the Syndicate on Academics and Research and resolved to modify the Clause III of the existing norms for granting University Research Fellowship mentioned under U.O. read as (1) above, as follows:

III. Extension of University Fellowship for the Third year of Research shall be issued if the research scholar has fulfilled the following conditions:

(a) The research scholar should submit any one of the following documents:

(i) Proof of the presentation of research oriented papers in a minimum of two National / International conferences duly endorsed by the Chairman Doctoral Committee and counter signed by the Research Director.

(ii) Proof of the Publication of one research oriented paper in any academically established journal complying the UGC regulations duly endorsed by the Chairman Doctoral Committee and counter signed by the Research Director.

(iii) Proof of the Publication of one Book Chapter with ISBN /ISSN Number duly endorsed by the Chairman Doctoral Committee and counter signed by the Research Director.

(b) The assessment of second year of research work of the scholar shall be done at the Research Centre. The Assessment Report certified by the Research Supervisor, countersigned by the Head of the Research Centre, to be submitted to the Doctoral Committee, Chairman. The Doctoral Committee, Chairman shall forward the Assessment Report with due verification of recommendation along with application for renewal of fellowship to the Registrar.

Sanction has therefore been accorded by the Vice-Chancellor to implement the revised norms as resolved by the Syndicate.

University order read as (1) above stands modified to the this extent.
