How To Apply

The application should include the following details:

- (1) Name of the journal submitted for Grant in aid to research journals
- (2) Evidence to show that the journal is included in the UGC-Care list (Evidence as given in the University Grants Commission- Consortium for Academic and Research Ethics (UGC-CARE) website
- (3) Month and year in which the journal is included in the UGC CARE List.
- (4) Month and Year in which the journal originally started publishing
- (5) ISSN number of the journal

NB: All the relevant documents submitted along with the copy of the journal to be attested by the Principal of the respective college.

The application along with the above documents, duly recommended and forwarded by the Principal, shall reach this office on or before 15.12.2024.

ORDER

An amount of Rs.5,00,000/-(Rupees Five lakh only) has been earmarked to encourage and support journals published by the affiliated colleges associated with the University on a range of topics listed in the UGC Care List as envisaged in the Budget Speech 2024-25, item no.59

The meeting of the Budget implementation Cell held on 13/09/2024, vide paper read as (1) above has decided to entrust Director, Research and the Director, IQAC to submit the proposal and to place the same before the Combined meeting of the Standing Committee of the Syndicate on Academics & Research and Standing Committee of the Syndicate on Finance.

The Director, Research has submitted the proposal as detailed below

In order to promote publishing journals from affiliated colleges a scheme has been introduced to provide financial assistance. Only UGC-Care listed journals will be considered for this scheme. An amount of Rs 5 Lakhs has been earmarked for this in the Budget 2024-25. Overall selection process for awarding the publishing grant has to be routed through the office of IQAC.

Method of operation

- 1.To invite applications from eligible colleges by notifying in the University Website.
- 2. Applications along with a copy of the latest issue of the published journal shall be forwarded to Director IQAC.
- 3. The application shall be forwarded duly recommended by the Principal.
- 4. There should be a specific time frame for the submission of application.
- 5.The initial application processing is to be done at IQAC
- 6.After the initial screening of checking whether the applications are in order, it can be forwarded to the Selection Committee.

SELECTION COMMITTEE

will consist of the following members

- (i) Convener of the Standing Committee of Syndicate on A&R (Chairman)
- (ii) Director, IQAC Convener
- (iii) Dean, Faculty of Science
- (iv) Dean, Faculty of Arts
- (v) Dean, Faculty of Social Sciences
- (vi) Dean, Faculty of Applied Science and Technology
- (vii) Research Director.
- (viii) Joint Director, IQAC



- How much amount to be sanctioned to a particular journal will be decided by the committee based on the quality of the Journal.
- After the selection it may be placed in the Standing Committee of the Syndicate on A&R
- Finally, will be placed in the Syndicate for final approval.
- Once the Syndicate approves the financial assistance, University Order has to be issued.
- *Mechanism of how to disperse the money to the research scholars has to be decided in consultation with the Finance Officer.*
- The colleges receiving money needs to submit a report to University.

The Syndicate vide paper read as (2) above has resolved to approve the proposal submitted by the Director, Research on "Journal publishing Grant to Affiliated Colleges" as envisaged in the Budget Speech 2024-2025, item no.59 and to include following members in the Selection Committee mentioned above.
