ORDER

As per University Order read as (1) above, certain categories were permitted to register for Ph.D. Research in Part-time mode at the University of Kerala, provided they were otherwise eligible. Procedures for permitting Ph.D. programmes through Part-time mode are mentioned under Clause 13 of the University Grants Commission (Minimum Standards and Procedures for Awards of Ph.D. Degree) Regulations, 2022. The University of Kerala has implemented these Regulations vide U.O. read as (2) above.

The Syndicate, vide paper read as (3) above, considered the matter of granting permission to candidates for pursuing PhD research in Part-time mode, along with the recommendations of the Standing Committee of the Syndicate on Academics and Research, and resolved to grant Part-time Ph.D. registration to applicants who satisfy all eligibility conditions stipulated in the UGC Regulations 2022, subject to approval of the Academic Council. The Syndicate also resolved that the existing ceiling of 25% of the Ph.D. position vacancies for Part-time candidates will be continued in accordance with University Orders in force, subject to approval of the Academic Council.

The Academic Council, vide paper read as (4) above, considered the matter and resolved to grant Ph.D. registration in Part-time mode to applicants who satisfy all eligibility conditions stipulated in the UGC Regulations 2022. Further resolved that the existing ceiling of 25% of the Ph.D. position vacancies for Part-time candidates will be continued in accordance with University Orders in force.

Sanction has therefore been accorded by the Vice-Chancellor to grant Ph.D. registration in Part-time mode to applicants from July 2024 Session onwards, provided they satisfy all eligibility criteria stipulated under Clause 13 of the UGC Regulations 2022, subject to the condition that the existing ceiling of 25% of subject wise vacancies available in each session shall be continued. The above ceiling will not be applicable to the categories (c) and (d) as mentioned in the U.O. read (1) above.

University Order read as (1) above stands modified to this extent.

Orders are issued accordingly.
