ORDER

As per U.O (read 1 above), Ph.D research scholars who have registered prior to July 2009 session and who have not submitted their thesis or synopsis were permitted to appear for Coursework examination.

The Syndicate at its meeting held on 26.03.2013 considered along with the recommendation of the Standing Committee of the Syndicate on Scholarships, the matter of granting permission to research Scholars who have registered prior to July 2009 session, to appear for Course work along with the submission of Synopsis/Thesis and recommended the following.

- Those who have been awarded their Ph.D Degree cannot appear for the 1. coursework examination
- Those who have not submitted the Synopsis may appear for coursework 2. examination and pre-submission Seminar, before the submission of the thesis
- Those who have submitted their synopsis/thesis but not awarded the Ph.D Degree 3. may appear for coursework examination. But those who have submitted the Ph.D thesis will not be permitted to do the pre-submission seminar. Open Defence will be conducted after the passing of course work examination.
- The candidates opting for the course work examinations are given three 4. consecutive chances to appear for coursework examination.
- If the candidate decides to opt for coursework examination after the submission of 5. thesis, the award of the Ph.D Degree will be kept in abeyance, till the candidate clears the same.
- If the candidate opts out of coursework examination/pre-submission or both after 6. they have applied for the same, the Ph.D Degree may be awarded without considering the coursework examination and pre-submission seminar.

Sanction has been accorded by the Vice-Chancellor to implement the above decision of the Syndicate.

Orders are issued accordingly.
