ORDER

The Research Scholars availing/to avail Junior Research Fellowship/Senior Research Fellowship (including upgraded from UGC JRF to UGC SRF) were not sanctioned their fellowship on time due to the procedural delay in the release of grants in-aid from the funding agency.

Taking into account of the hardships being faced by the research scholars, the Standing Committee of the Syndicate on Finance, vide paper read (1) above had recommended to extend an Interim Relief of Rs.6,000/- (Rupees Six Thousand only) per month for a period of one year to all the Junior Research and Senior Research Fellows [excluding the forty four UGC JRF research scholars whose selection interview was conducted on January 28, 2012 (as their candidatures are yet to be reckoned with by the UGC (list appended) as per University Notification of December 2011].

The Vice-Chancellor has accorded sanction of Rs.6,000/- (Rupees Six Thousand only) per month for a period of one year to the UGC JRF's/SRF's on the basis of paper read (1) and the Finance concurrence vide paper (2) read above excluding the 44 numbers of new UGC JRF's whose selection interview was held on 28.01.2012, subject to ratification by the Syndicate.

The Heads of the Departments/Principals concerned must specifically certify the same in the Interim Relief Claim Bill to be furnished along with comprehensive Progress Report/Attendance Statement for the purpose.

An amount of Rs.80,64,000/- (Rupees Eighty Lakh Sixty Four Thousand only)has been earmarked from the Kerala University Fund for the disbursal of the Interim Relief of Rs.6,000/- (Rupees Six thousand only), each per month for an year for 112 candidates of UGC JRF/SRF.

The Head of the Departments/Principals may verify eligibility of Research Fellows before disbursing of the Interim Relief.

The expenditure towards the same will be debited to "Part III – M.H.80B – Funds from UGC 9/7301 – UGC Research Fellowships" provided in the current year's budget estimate of the University.

The amount disbursed shall be recouped once funds are received from UGC as Junior Research and Senior Research Fellowships (as indicated in the earlier SRF Interim Relief purported in the U.O's read as paper (3) above).
